PURPOSE:

- This person will function as a scientific expert with the reproductive medicine community to facilitate the development of collaborative partnerships in the area of infertility. He/she will utilize EMD Inc. medical and scientific information on research developments, new concepts in reproductive medicine, treatment, and continuing medical education activities to build relations with key thought leaders. As a member of the cross-functional Fertility team, this individual will contribute to the development and implementation of the Canadian medical strategic plan, with a priority being the development of medical thought leaders as advocates, the dissemination of state-of-the-art research and scientific concepts related to the treatment and management of infertility and the evaluation of local requests for investigator-driven studies and Phase IIIb-IV studies. He/she will work closely with the Director of Scientific Affairs and the Marketing and Sales teams.
- Based upon personal interest, business needs, and rotation time, the intern will be
 assigned to a wide selection of tasks and projects within the Medical Department with the
 objective to gain insights into the complexity of the responsibilities and services provided
 by this department and its interactions with the rest of the organization (Regulatory,
 Marketing, Sales)

- Collaborate with Marketing, Sales, Scientific Affairs, and Government Access teams by providing the scientific rationale for use of EMD Inc. therapies
- Review and evaluate scientific publications, and develop, in collaboration with Medical and Marketing teams, key message summaries for dissemination by the Key Account Managers as per existing standard operating procedures to ensure compliance
- Contribute to the internal scientific training, when required
- Identify and report literature-based and field intelligence on key competitor activities to the Medical Director and Director of Scientific Affairs
- Participate in assigned regional, national and international scientific meetings, and prepare summaries on meeting highlights

- To execute projects as assigned at the beginning of rotation, i.e., lead a project of developing a protocol for Phase IIIb study and obtain all required internal and external approvals, coordinate Grant for Innovation in Fertility, coordinate and participate in other activities with scientific/medical content
